The Coaching Institutes have at least 20 years experience in the field and who have more than 10000 selected students in each streams (IIT/JEE/AIEEE and NEET/PMT).

The reputed Institutes may send their Expression of Interest upto 17.04.2017 to the Chief Executive Officer, Mewat Development Agency, Housing Board Colony, Taoru Road, Nuh District Nuh (Haryana)-122107 alongwith required details and proposal as per terms and conditions.

## **Terms and Conditions for inviting Expression of Interest**

1. The selection of students will be made by the Institute through a competitive exam under the supervision of MDA. The students who have passed/appeared in their secondary examination from Mewat Model Schools and Government Schools of Nuh District and wish to continue their education in these schools only, will be eligible to participate in competitive exam.
2. The coaching should be provided at Nuh itself. In case it is not possible, it may be provided in neighbouring towns i.e. Palwal or Gurugram. Preference may be given to those coaching institutes who provide coaching for both streams (IIT-JEE as well as NEET/PMT).
3. The batches should be a weekend with classes on Saturdays and Sundays.
4. An affidavit will be taken from parents/guardians that if their wards leaves the course or absent himself/herself for prolonged duration (more than two weekends/weeks) he/she may be rusticated after giving opportunity for show-cause and if the reply is unsatisfactory, the fee paid by MDA will be recovered from them.
5. If the coaching institute is outstation, transport facility may be arranged by MDA.
6. The Coaching Institute must be reputed who have at-least 20 years of experience in the field and who have more than 10000 selected students in each stream (IIT-JEE as well as NEET/PMT) from their regular classroom courses. The students selected through correspondence courses should not be counted as successful candidates.
7. The MoU will be signed with the Institute preferably for 3 years extendable for another year on the basis of the results.
8. The MoU must contain a clause for objective parameters like percentage of successful candidates expected because the students will be a selected meritorious lot and a higher success percentage is expected. Some amount of payment (15-25%) should be performance linked and must be paid after results are out.
9. The Institute should give some discount to MDA as there will a bulk business for them and the students selected are meritorious ones.
10. There should be pinching penalty clause for non performance/mid-session default of terms and conditions of MoU.
11. The selected Institute must ensure that there is no adverse discrimination towards MDA sponsored students in teachers' or study material or tests quality.
12. CEO MDA will be the Nodal authority to deal with institute and for disciplinary matters regarding the students.
