- 6. In case of unsatisfactory service, agreem\*--ent will be terminated without assigning any reason and giving any notice.
- 7. Vegetables, fruits and other eatables will be provided fresh. If the vegetables & fruits are found of bad/ poor quality, fine will be imposed by the Principal.
- 8. Flour, spices will be used of Agmark & cooking oil will be used ISI mark only.
- 9. You will ensure the absolute cleanliness of kitchen and dining hall.
- 10. Medical check-up of the cooks will be carried out quarterly by an MBBS Doctor and a certificate to this effect will have to be submitted to the Principal.
