**Proceedings of the 25<sup>th</sup> meeting of the Governing Body, Mewat Development Board held on 17-06-2010 at 12:00 noon in the Conference Hall of Raj Bhawan, Haryana under the Chairmanship of H.E. The Governor, Haryana Shri Jagannath Pahadia, Chairman, Mewat Development Board, Chandigarh**

List of Members and Special invitees present in the meeting is enclosed at Annexure-A.

At the outset H.E. The Governor of Haryana and Chairman Mewat Development Board welcomed all the members. His Excellency briefed the members about the ongoing schemes and appreciated the work done by MDA in various fields.

His Excellency emphasized that there is need for taking up special programmes in some selected areas so that the limited resources of MDA could be put to maximum benefit of the people. His Excellency suggested that more emphasis should be given on the education specially the women education, health and social development. H.E. also suggested that in the field of education and technical education the model of Public Private Partnership should be thought of. Besides above, H.E. also mentioned that it will be appropriate if more employment opportunities are made available for the people of Mewat area.

With the permission of the Chairman, MDB, the itemwise agenda was taken up and following decisions were taken:

**Item No.25/1                      Confirmation of minutes of 24<sup>th</sup> meeting of Mewat Development Board held on 9-7-2008.**

**Item No.25/2                      Follow-up action on the decisions of the last meeting of the Board held on 9-7-08.**

Follow-up actions on the decisions of the last meeting of Mewat Development Board held on 9-7-2008 were explained by the concerned departments and the action taken was noted with the following observations:

- (i) The cases of transfer of land for establishment of polytechnics in Malab and Rewasan villages be expedited and the land be transferred to the Department of Technical Education within fifteen days.

- (ii) The HSIIDC will prepare a plan for utilization of land of Co-operative Department transferred to Municipal Committee, Nuh and execute the same. The HSIIDC will provide funds to Municipal Committee, Nuh for purchase of land so that the sale deed is registered in the name of M.C.Nuh. The HSIIDC will work out the modalities of utilizing the land on sharing basis with the Municipal Committee.
- (iii) Suitable land for establishment of Driving Training School be provided and transferred to Transport Department. The Deputy Commissioner, Mewat would initiate the process of transfer of the land to the Transport department.
- (iv) It was decided that Financial Commissioner & Principal Secretary, Social Justice & Empowerment and Financial Commissioner & Principal Secretary PWD (B&R) and Financial Commissioner & Principal Secretary, Elementary Education to be included as official members of the Board.
- (v) It was decided that MDA should rope in the services of reputed NGOs in implementing the various schemes of MDA.


**Review of Progress and approval of expenditure incurred under On-Going Scheme from 1.4.2008 to 31.3.2009.**

- i) Approved the expenditure of Rs. 1071.50 lacs during the period from 1.4.2008 to 31.3.2009.
- ii) Expost facto approval was accorded for utilizing the unspent balances of Rs. 228.50 lacs during the financial year 2009-10.

**Item No. 25/4**

**Revised Annual Work Plan & Budget 2009-10 of MDA and approval of expenditure incurred from 1.4.2009 to 31.03.2010 under On-Going Scheme (State Funded).**

Discussed and approved the revised AWP&B 2009-10 and expenditure of Rs. 1729.63 lacs and expost facto approval was also accorded to utilize the unspent balance of Rs. 270.37 during the financial year 2010-11.

The House approved the AWP&B 2010-11.

**Item No. 25/6 Multi-Sectoral Development Plan, Ministry of Minority Affairs, Govt. of India.**

The House noted the progress of Multi-Sectoral Developmental Plan and approved the action taken by MDA to implement the scheme. It was also decided that the proposals for construction of Anganwari centres be sent to the Govt. of India under the above scheme.

The change of location of PHC from Ujina to Marora and CHC from Nagina to Pinangwan was approved by the House.


**Item No. 25/8 Lending schemes of National Minority Development Finance Corporation, New Delhi.**

The agenda was discussed in detail and the implementation of the lending scheme of NMDFC in Mewat area was approved. The issue regarding sanction of additional posts taken up separately. In the meantime, MDA may appoint a few suitable retired employees on contract basis.

**Item No. 25/9 Approval of School of Science and Maths at Nagina.**

Approved the action taken by MDA. The Member Secretary informed that the site of School at village Madhi in Nagina Block has been selected. It was decided that the proposal for construction of school building be sent to the Ministry of Minority Affairs, Govt. of India under Multi-Sectoral Development Plan through State Govt.
