The Member Secretary, MDB welcomed all the Members, officers of various departments. Further, the House was briefed about the objectives and activities of the Board & Mewat Development Agency.

With due permission from the Chair, the agenda was taken up and after deliberations, following decisions were taken:

Item No.29/1 Confirmation of minutes of 28th meeting of Mewat Development Board held on 14.12.2016.

The minutes of the 28th Meeting of the Board were confirmed.

Item No.29/2 Follow-up action on the decisions of the last meeting of Mewat Development Board.

The Action Taken Report on the decisions of the 28th meeting of Mewat Development Board held on 14.12.2016 was discussed and noted with the following observations:

Item No. 25/2:

Follow-up action on the issues decided in the meeting of MDB held on 17.06.2010.

Setting up of Institute of Driving Training & Research at Mewat.

The matter regarding issue of heavy licenses to the drivers having invalid driving licenses was discussed and it was decided that a committee under the chairmanship of PSCM comprising Transport Commissioner, Commissioner,

Gurugram Division and Deputy Commissioner, Nuh was constituted to suggest options for sorting the issue within 15 days.

Item No. 25/10

Repair and Maintenance of Housing Board Colonies in Mewat Region.

It was decided that since the matter relates to the PWD (B&R) Department, the same would take further necessary action.

Supplementary Item No. 25/1

Approval of Hospitality Management Institute at Nuh

It was decided that since the matter related to the Tourism Department, hence, the same would take further necessary action.

Item No. 26/5

Multi-Sectoral Development Plan, Ministry of Minority Affairs, Govt. of India.

The General Manager, NBCC, New Delhi informed that the all incomplete works would be completed by 30.09.2017 and staff quarters at MMS Hathin will be completed by 31.10.2017.

Item No. 28/8

Management of Mewat Model Schools, Kasturba Gandhi Balika Vidyalya and Arohi Model Schools in Mewat area.

The ACS, School Education informed that the KGBVs would be handed over to MDA at the earliest possible.

Item No. 29/3 The Annual Work Plan & Budget 2017-18 of MDA.

The Annual Plan 2017-18 for Rs. 34.50 crore was approved with the suggestion that the programme for improvement of health of women and child may also be initiated.

Item No. 29/4 Arrangement of female teaching staff for upliftment of girls' education in Mewat area.

The matter was discussed in detail and it was decided that the unemployed youth of the area having qualification of D.Ed/JBT, Graduation and B.Ed may be registered under "Saksham Yuva Scheme" of Government and their services may be utilized in the schools and remedial coaching as per the requirement.

Item No. 29/5 Setting up of Regional Centre of Gurugram University in district Nuh.

Since the agenda item related exclusively to the Education Department, it was skipped.

Item No. 29/6 Setting up of Sports School in district Nuh.

Since the agenda item related only to the Sports Department, it was skipped.

Item No. 29/7 Setting up of 03 new Mewat Model Schools.

The proposal was deferred as it requires further examination. It was further directed that steps may be taken by the MDA for self-sustaining the existing Mewat Model Schools.

Item No. 29/8 Construction of Auditorium at Nuh.

Since the agenda item related only to the PWD (B&R) Department, it was skipped.

Item No. 29/9 Mewat Feeder Canal.

Since the agenda item related only to the Irrigation Department, it was skipped.

Item No. 29/10 Transfer of land of 6 acres in the name of Ayush department for setting up of Unani Medical College at village Akera, Nuh free of cost.

It was directed that fresh resolution by the Gram Panchayat, Akera for transfer of 6 acres of land free of cost to the Ayush Department for setting up of Unani Medical College at village Akera be sent by the Deputy Commissioner, Nuh to the Government for consideration.

Item No. 29/11 Setting up of University in Mewat.

Since the agenda item related only to the Higher Education Department, it was skipped.

Item No. 29/12 Setting up of Skill Development Centre at village Rewasan.

Since the agenda item related only to the ITI and Skill Development Department, it was skipped.

Item No. 29/13 Setting up of Dental College at SHKM, Medical College Nalhar and to start the B.Sc Nursing, Physiotherapy and B. Pharma etc. courses.

Since the agenda item related only to the Medical Education and Research Department, it was skipped.

Item No. 29/14 50% reservation in government jobs and MDA/Mewat Model Schools for the residents of Mewat area.

The agenda item was held to be unviable and hence disapproved.

Item No. 29/15 Setting up of Polytechnic at F.P. Jhirka and Punhana.

Since the agenda item related only to the Technical Education Department, it was skipped.

Item No. 29/16 Setting up of International level Vegetable and Fruit selling market at Tauru and centre for excellence of fruits and vegetables in district Nuh as announce by the Government.

Since the agenda item related only to the Agricultural Marketing Board Department, it was skipped.

Item No. 29/17 Providing modern equipments in Sports Stadiums of the area and transfer the stadiums to MDA.

Since the agenda item related only to the Sports Department, it was skipped.

Item No. 29/18 Setting up of Kisan Park for providing trainings and awareness of modern techniques and Hybrid Seeds of Agriculture & Horticulture for income generation of the farmers of the area.

Since the agenda item related only to the Agriculture Department, it was skipped.

Item No. 29/19 Extension of Nuh Distributory.

Since the agenda item related only to the Irrigation Department, it was skipped.

Suppl. Item No.1 Since the agenda item related only to the Forest Department, it was skipped.

Suppl. Item No.2 Since the agenda item related only to the Forest Department, it was skipped. However, Hon`ble Chief Minister directed that the illegal mining activities in the Mewat area be stopped.

Any other item with permission of chair:

Hon`ble Chief Minister draw the attention of the board to para 2 of notification of Agriculture Department dated 16.01.1980 which lays out the objectives of the Board. He directed that a study may be carried out to ascertain on which indicators the area still lags behind the state average. Based on this, the Board should focus its resources to only those schemes which would help Mewat improve on such indicators.
